

PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

FOR CONTROL OF TWO SPOTTED MITE IN SWEETCORN, CHILLIES, PAPRIKA, SPRING ONIONS AND SHALLOTS

PERMIT NUMBER - PER14536

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

THIS PERMIT IS IN FORCE FROM 30 MAY 2014 TO 31 DECEMBER 2023.

Product to be used:

VERTIMEC MITICIDE/INSECTICIDE (50772) PLUS OTHER REGISTERED PRODUCTS

Containing: 18 g/L ABAMECTIN as their only active constituent.

VANTAL UPGRADE MITICIDE/INSECTICIDE (67524)

PLUS OTHER REGISTERED PRODUCTS

Containing: 36 g/L ABAMECTIN as their only active constituent

Critical Use Comments:

- Apply with a properly calibrated boom sprayer or equivalent in sufficient volume to penetrate the plant canopy and evenly cover the plant surfaces.
- DO NOT Apply more than 2 applications per crop.
- Allow at least 28 days between applications.
- Apply before pest populations reach economic damaging levels.

Withholding Period:

Sweet corn: DO NOT harvest, graze or cut for stockfood for 21 DAYS after application. Chillies, paprika, spring onions, shallots: DO NOT harvest for 3 DAYS after application.

Jurisdiction:

All States except VIC.

(<u>Note</u>: Victoria is not included in this permit because their 'control-of-use' legislation means that a permit is not required to legalise this off-label use in VIC).

Additional Conditions:

To Avoid Crop Damage:

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.

Export of treated produce

Use of abamectin may result in detectable residues in sweet corn, chillies, paprika, spring onions and shallots and not all countries have established tolerances for abamectin. If treated produce is to be exported due account should therefore be taken of the residue definition and residue limits/import tolerances of importing countries and that any residues must not exceed those requirements.

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.
