THE ENVIROVEG PILOT PROGRAM

The EnviroVeg program is evolving over this five year project by developing robust, up-to-date resources and processes and focusing on driving recognition to benefit members and educate communities.

This pilot program is a funded pathway through EnviroVeg to reach Freshcare Environmental certification and attain the best practice benefits of environmentally responsible, sustainable vegetable production.

By following the pilot program structure (below), thirty vegetable production businesses will transition through the program and have all costs covered in order to achieve third party Freshcare Environmental certification through EnviroVeg. The pilot will take place over a year, depending on the availability and schedule of applicants.


