#### **CONDITIONS OF USE**

#### **Products to be used:**

NUFARM CHLORPYRIFOS 500 EC INSECTICIDE (APVMA No. 32902) PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/L CHLORPYRIFOS as the only active constituent.

#### **RESTRAINT:**

This product is too hazardous for use by householders, householders must not use this product in or around the home.

Not for use in the home garden.

#### **Directions for Use:**

Crop	Pest	Rate
Sweet corn	African Black Beetle	20 mL / 100 m of row
	(Heteronychus arator)	Or
		2 L / ha for row spacing of 1 metre

#### **Critical Use Comments:**

- Apply to no greater than 30 hectares per day.
- Apply using a minimum of 20 Litres of water per hectare.
- Apply at sowing as a 15-20 cm band spray. For best results spray nozzles should be in front of press wheels on planter.
- DO NOT apply more than 1 application per crop.
- Apply using a boom spray or equivalent.
- Apply by spraying the entire furrow behind the seed tube. Ensure all spray is directed into the furrow contacting the bottom and sides, and that all soil is drawn into the furrow at closure.

# Withholding Period:

Harvest: Not required when used as directed.

Grazing: DO NOT graze or cut for stock food for 4 weeks after application.

#### Jurisdiction:

All States and Territories.

#### **Additional Conditions:**

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Continued issuance of this permit is subject to the outcomes of the current APVMA review of chlorpyrifos. This permit may be impacted by the outcomes of this review.
